## Section 2 - Hazards Identification

### Statement of Hazardous Nature

This product is classified as: Not classified as hazardous according to the criteria of SWA.

## Emergency Overview

**Physical Description & Colour:** Dark brown to black solid.

**Odour:** Non specific earthy odour.

**Major Health Hazards:** no significant risk factors have been found for this product. Inhalation of dust and/or liquid mists (bio-aerosols) from these products may result in respiratory irritation, inflammation or sensitisation resulting in illnesses ranging from hay fever and asthma to pneumonia and pneumonia like illnesses (eg Legionnaire's disease).

## Potential Health Effects

### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. However, may irritate, inflame or sensitise the nose, throat and lungs, and may aggravate pre-existing conditions such as asthma and bronchitis.

**Long Term Exposure:** No data for health effects associated with long term inhalation.

This product contains variable quantities of lime, dolomite and iron (for pH control).

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

### Section 4 - First Aid Measures

---

#### General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

**Skin Contact:** Gently brush away excess solids. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

**Eye Contact:** Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water until the particles are removed, while holding the eyelid(s) open. Obtain medical attention if irritation persists, or if particles are lodged in surface of the eye(s). Take special care if exposed person is wearing contact lenses.

### Section 6 - Accidental Release Measures

---

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable

Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Consider vacuuming if appropriate. Recycle containers wherever possible after careful cleaning. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. ---
